The Arc of El Paso has been part of the El Paso community for almost forty years, and we continue to work tirelessly to build an equitable, just and strong community, acting as a hub for individuals with intellectual and developmental disabilities and their families through delivery of services and education.

2020 was a year of frustration and isolation for so many due to the COVID-19 pandemic and The Arc of El Paso found itself like so many needing to reschedule and rethink activities for the year while praying people would be safe. We took advantage of this change of pace to reflect on who we have been as an organization and where we want to go by completing a strategic plan and began two separate yet closely-related grant activities related to COVID-19 and were awarded a grant for services to launch at the start of 2021. During 2020 one of our major activities was the completion of a strategic plan to help us consider and plan for our future. We evaluated the needs of families and increased our electronic and remote presence by continuing our electronic newsletter, maintaining the relevancy of our website, moving training from in-person to remote training, and growing our social media footprint. We even took time to acquire physical space at Sunland Park Mall as we plan beyond the pandemic.

I am thankful for the support of the Board of Directors, and together we remain grateful for the support of our community during this global pandemic and welcome your review of this annual report and our accomplishments during 2020.



The pandemic brought a change from face-to-face meetings and trainings to online. We had a quite a year with multiple board meetings and work sessions and trainings focused on future planning.




Important Things to Remember

What We Did

2020 was a year the world focused on COVID-19 and caused us to cancel virtually all of our face-to-face events. We regrouped and had a busy year.

Advocacy, Consultation and Assistance

During 2020 51 families were provided advocacy and consultation services with several contacts coming from out of state looking for help for a family member in El Paso. Information was provided in-person, over-the-phone, and via email with questions and concerns answered with information provided about benefits, employment, education, and healthcare with age ranges from three to fifty-seven. During the pandemic, we provided food assistance to 11 families. Overall we experienced at 31% increase in contact with families.

Social Drop-In Center

We acquired space at Sunland Park Mall with a rental responsibility to solely contribute to utility costs. The space was renovated during 2020 with furnishings either donated, sponsored, or purchased at a nominal cost. The Social Drop-In Center will become our hub of activities in El Paso. We purposely limited access to the center due to a surge in COVID-19 infections in our community.

Arc Ambassadors

Through grant funding we hired 3 part-time Arc Ambassadors who represent the organization in community events either online or in person when it is safe to do so, who help create videos using basic language related to COVID-19, and who act as a host to the Social Drop-In Center.

"As an Arc Ambassador I get to use my imagination making scripts for videos about COVID-19 and accessibility. What I do is important because it helps to teach the IDD community about COVID-19 and educates the community about accessibility for people with disabilities.

Having this job keeps me busy and gives me the chance to earn some money. I have the opportunity to work with people remotely which is better than staying home and doing nothing.

I want life to get back to normal as quick as possible so I can work with people in the community."

"I write not to take a side in that debate, but to ask you to consider that the restrictions imposed by these emergency orders and curfew might give you a glimpse into the everyday reality for individuals with intellectual and developmental disabilities. The isolation and frustration that some may feel as a result of these emergency orders and curfew is part of everyday life for many individuals with intellectual and developmental disabilities. They felt this isolation before COVID-19, and many will experience this isolation after COVID-19 is a memory."

Social Media and Electronic Newsletter Presence

During 2020 our Facebook page likes grew by 60%. Twitter, Instagram, and LinkedIn pages were also used for The Arc of El Paso. Our newsletter grew to 268 contacts, an increase of 312%.

Strategic Plan

Through grant funding and in collaboration with Incite Consultancy, we completed a strategic plan to propel our services to better meet the needs of our community.

Trainings


Seven trainings were provided to 127 participants during 2020 with another 886 viewing through Facebook video. Trainings focused on future planning, understanding benefits and ABLE Accounts, and listening to the needs of our community. While we had few trainings due to the pandemic, we did see a 37% increase in participation.

Promises Made, Promises Kept

Concluding El Paso Community Foundation and The Walter H. Hightower Foundation Grant

During 2020 The Arc of El Paso successfully started and brought to a conclusion our strategic planning process which was funded through The Walter H. Hightower Foundation through the El Paso Community Foundation. During the process we worked with Incite Consultancy to develop the strategic plan.

In 2020, we experienced the global effects of COVID-19 that disrupted many aspects of our daily lives. From the psychological impacts of social isolation to the socioeconomic impacts on our community, our nation, and the world, the pandemic has revealed significant equity gaps on multiple levels, especially as it applies to access to care and available resources for the people we serve: people with disabilities, their families, the environments that support them. community's needs through this new lens.



Amerigroup Sponsorship

We received funding from Amerigroup to host several events during 2020 some of which have been deferred to 2021 due to the pandemic. Amerigroup sponsored our computer lab in the Social Drop-In Center.

Grants Received

During 2020 we received a grant from the Edith Zanker Fund through the El Paso Community Foundation that provided funding to hire one of our Arc Ambassadors.

Two additional Arc Ambassadors were hired through a grant provided by the Paso del Norte Health Foundation. Arc Ambassadors represent The Arc of El Paso at remote or when it is safe, in-person events and create videos about COVID-19 safety and other topics important to people with disabilities.



In 2021, we will continue our legacy of promises made, promises kept, following through on our promise with the El Paso Community Foundation and Paso del Norte Health Foundation. We also acknowledge with gratitude the more than \$7,200 in donations we received through El Paso Giving Day, including matching funding from Walmart Foundation. This represents a 21% increase in donations on El Paso Giving Day over the previous year.

Legacy Donor

During 2020, The Arc of El Paso received a strategic donation from Guerra Investment Advisors on El Paso Giving Day for which we are grateful.
